The Minutes from the Meeting held on March 8, 2011, were approved by the Enrollment and Student Services Committee Members.

ISSUES BOX or Items for Future Agenda: Student Action Policy

Topic 1 [Presenter 1]

Discussion: **“Student Participation in Intercollegiate Athletics Policy”**

The final draft of the **“Student Participation in Intercollegiate Athletics Policy”** was discussed by the Committee and edited to reflect the recommendations of the All College Council. Regarding the College’s compliance with Title IX, the intent of the Enrollment and Student Services Committee was that this Policy apply to Male and Female Athletes equally. However, the College should address Title IX compliance ‘somewhere else.’

Conclusions: John Solaperto made a motion to approve the **“Student Participation in Intercollegiate Athletics Policy”** and re-submit the Policy to the All College Council. Kelly Lamond seconded the motion.

Topic 2 [Presenter 2]

Discussion: **Review Information from Student Senate on Parking. Respond to All College Council concerns regarding a written policy for issuing Faculty/Staff Parking Permits to students with disabilities.**

John Solaperto, Chair, Enrollment and Student Services Committee, and Pat Schmohl, Chair, Administrative Services Committee, agreed that any work on formalizing a policy on the issuing of Medical Parking Permits will be conducted by the Administrative Services Committee and forwarded to the Enrollment and Student Services Committee for input, prior to being sent to the All College Council. In response to the All College Council’s request regarding the issuing of Medical Parking Permits to Students with Disabilities, the Enrollment and Student Services Committee provided the following:

Although there is no policy in place, the “Parking Rules and Regulations” were adopted by the Board of Trustees under powers granted by Chapter 15A, Section 13, of the Massachusetts General Laws, and are “subject to subsequent amendment” as noted in the preamble of “Parking Rules and Regulations.”

Conclusions: Vice President Steve Sullivan will check with Lori Corcoran, Associate Dean of Disability Services, regarding the policy. **(As stated in the Student Handbook, “Parking for students with medical reasons has to be approved through Disability Services.”)**
